## **DNREC Launches Online Flood Planning Tool**

#### I-ADAPT Helps Residents Identify Strategies to Prepare For Flooding

Delaware residents can now take advantage of a new webbased tool designed to help them identify steps they can take to protect their property from flood damage.

The Department of Natural Resources and Environmental Control's Division of Climate, Coastal, and Energy and Division of Watershed Stewardship have launched I-ADAPT, the Individual Adaptation Decision and Planning Tool, to help Delawareans become more resilient to climate hazards, particularly flooding.

"Flooding is not something that impacts only our coastal communities," said DNREC Secretary Shawn M. Garvin. "Climate change is bringing more frequent and intense storms that result in flooding in our urban and inland communities. I-ADAPT can help identify ways that residents can prepare their homes and businesses before flooding occurs."

The Commission of Fine Arts is an independent federal agency charged with giving expert advice to the President, the Congress and the federal and District of Columbia governments on matters of design and aesthetics, as they affect the federal interest and preserve the dignity of the nation's capital. The Commission is composed of seven presidentially appointed experts in relevant disciplines including art, architecture, landscape architecture, and urban design.

The Commission reviews designs proposed for memorials, coins, medals, and new or renovated government buildings, as well as privately owned properties in certain areas of Washington under the Shipstead-Luce and Old Georgetown Acts. In addition, the Commission supports a variety of arts institutions in Washington, DC, through the National Capital Arts and Cultural Affairs (NCACA) program.

Through its unique work as the only federal commission dedicated to design review and aesthetic excellence, the Commission of Fine Arts serves the American people, international visitors, and those who live and work in the nation's capital, contributing to the beauty and dignity of this international symbol of American democracy.



## Welcome Back to NCARB!

For a limited time, NCARB is waiving reactivation fees for anyone who has let their NCARB Record and/or Certificate lapse, as well as the application fee for the NCARB Certificate. Inactive Certificate or Record holders will only need to pay the renewal fee to reestablish their account, saving up to \$1,235 in reactivation fees.

From May 1 – June 30, 2023, architects can reactivate their NCARB Record/Certificate for just \$250, and licensure candidates can reactivate their NCARB Record for just \$85.

These groups are able to take advantage of this opportunity:

- Architects who have let their NCARB Certificate lapse
- Architects with an inactive NCARB Record who have never held an NCARB Certificate
- Licensure candidates with an inactive NCARB Record

## AXP Update: Download the New AXP Guidelines

We recently made some changes to the *Architectural Experience Program (AXP) Guidelines*. **There are no programmatic or policy changes**—the requirements for completing the AXP remain the same. The updates primarily focus on clarifications and formatting enhancements to improve the document's usability.

Some changes you'll find in the updated *Guidelines* are:

- The addition of notes throughout to clarify potential areas of confusion around current rules
- Edits to the setting O chart to clarify employment status and supervisor requirements
- Clarifying edits to the AXP Portfolio instructions
- New, more accessible layout

No updates have been made to program requirements, including AXP experience areas or tasks. These updates aim to make the *AXP Guidelines* clearer and more user-friendly without altering any policies or requirements.
